Civil War Photographs

The Archives of Michigan has a fairly large collection of photographs of Civil War soldiers and veterans. The individual portraits range from Civil War era carte-de-viste images of young men to photographs of aged veterans. These are arranged alphabetically by name in the general Biography Index drawers, and separately by unit and then alphabetically by name in a special card catalog drawer. Both indexes are located in the Reference Room of the Archives of Michigan. There are also some photographs in the collection of Civil War units and miscellaneous groups of soldiers, but the persons in these larger photographs are not identified individually. The same is true of reunion pictures of Civil War units, mostly taken prior to World War I.
