

Emmet County



Originally laid in 1840 as Tonedagana County, Emmet County was later officially organized in 1853. The county coordinates are Range 4W-6W and Township 33N-39N. Adjacent counties include Mackinac (north), Cheboygan (east), and Charlevoix (south).
