Cass County was officially organized in 1829. The county coordinates are Range 13W-16W and Township 5S-8S. Adjacent counties include Saint Joseph (east), Elkhart [IN] (southeast), St. Joseph [IN] (southwest), Berrien (west), Van Buren (north), and Kalamazoo (northeast).
